## Previous Message (March 28, 2018)

In an effort to keep our learners safe and to make you aware of potentially hazardous trends and behaviors among today's adolescents, we are sending you this information. One of those new trends is called 'Juuling.' Juuling is a discrete form of vaping, that has potentially long-term negative health effects. Being in possession of a Juul or using one on school property is prohibited.

<u>Juul</u> is a name-brand vaping device that is sleek, small, easily concealable and most often mistaken for a computer thumb drive. Sometimes, the device is no larger than a couple of inches long and 0.5 inches wide. The devices are so inconspicuous and innocent looking that it is difficult to spot. In fact, someone might be looking at a vaping device like a Juul and not even know it.

The use of a Juul or other electronic cigarette works by heating a liquid substance that is inhaled by the user. The type of liquid can vary from flavored water-type mixtures to nicotine or marijuana. Unfortunately, "juuling" has become a hot trend for adolescents, since many children believe it is safer than smoking tobacco. Please consider talking about the dangers of electronic cigarettes, vaping, and juuling.

We also wanted to make you aware of an eye-opening resource that could assist you with monitoring space if you suspect that your child is in risky, unhealthy behaviors. Through our work with local law enforcement agencies and substance prevention specialists, we have learned that children who are using drugs, will often "hide" it in their rooms, "in plain sight". Again, you may be looking at a controlled substance and not even know it! Please see the link below, which was developed through a collaborative effort led by the Lehigh County Drug and Alcohol Abuse Services, to learn more about potential hiding spots that are used by adolescents to conceal their drugs, alcohol and/or related paraphernalia.
