Blended/Hybrid Instructional Model of Learning for entire District Effective January 21, 2021

We **continue to empathize** with all of you during these most difficult times. Being, remaining, or learning to be flexible is requested for all of us. We are trying to provide the safest learning environment we can, as timely as we can. We will continue to empathize with all the changes and adjustments we make that impact your daily lives and schedules.

Huntingdon County continues at a substantial level of community transmission. We will continue to monitor our internal case counts (*14 day rolling) and communicate at the building level for positivity and close contacts (you can find any update for the buildings on our website under the schools tab). Having the red and blue group allows us to maximize social distancing as well as minimize close contacts and the spread of the virus. It is the safest for our children, staff and families.

Blended/Hybrid Learning Model Overview

The Huntingdon Area School District will remain on a hybrid schedule until further notice. Below is a schedule for when each group (**Red & Blue**) is to attend school. The schedule is projected out until the week after the end of Marking Period 3, which is the week of March 29. Please understand that this is only a projection for planning purposes for your families as well as our teachers. The ultimate goal is to return to 100%. Again, the district will remain on a hybrid schedule until further notice.
